Draft Results for the 12 months ending 31 December 2010

Overview

These results are presented as draft as at 29 January, 2011. Further amendments will be necessary as expenditure committed in the last month of the financial year is presented and debited from the TJN-IS account.

1 The draft results for the 12 months to 31st December 2010 show a profit of £3,376, the corresponding figure for last year was a loss of £944. All costs have been recovered from grants and the surplus represents income from Membership fees which were unusually deposited into the UK Coop Bank account (Oxfam UK £3,120) and interest received £256.

The grants income from, the Joseph Rowntree Charitable Trust, Norad, and Christian Aid have all supported and will continue to support TJN's Mobilising Tax Justice Strategy. In addition the Department of International Development (UK) draws towards the end of its' three year funding of the Poverty Reduction programme. Oxfam Novib's and Misereror grants have contributed to our research work, work to develop communications and to core costs. The second phase of the Financial Secrecy Index was awarded a second grant by Global Financial Integrity. And finally, in our efforts to develop and support a Latin American network and establish a regional secretariat, we have been able to support partners from Latin American countries in attending the Council meeting and World Social Forum here in Dakar. This is thanks to Fastenopfer.

Carried Forward Income

4 Carried forward income (unspent grants) at 31st December 2010 amounted to £131,965

This represents a £27,747 increase over the deferred income at 31st December 2009.
